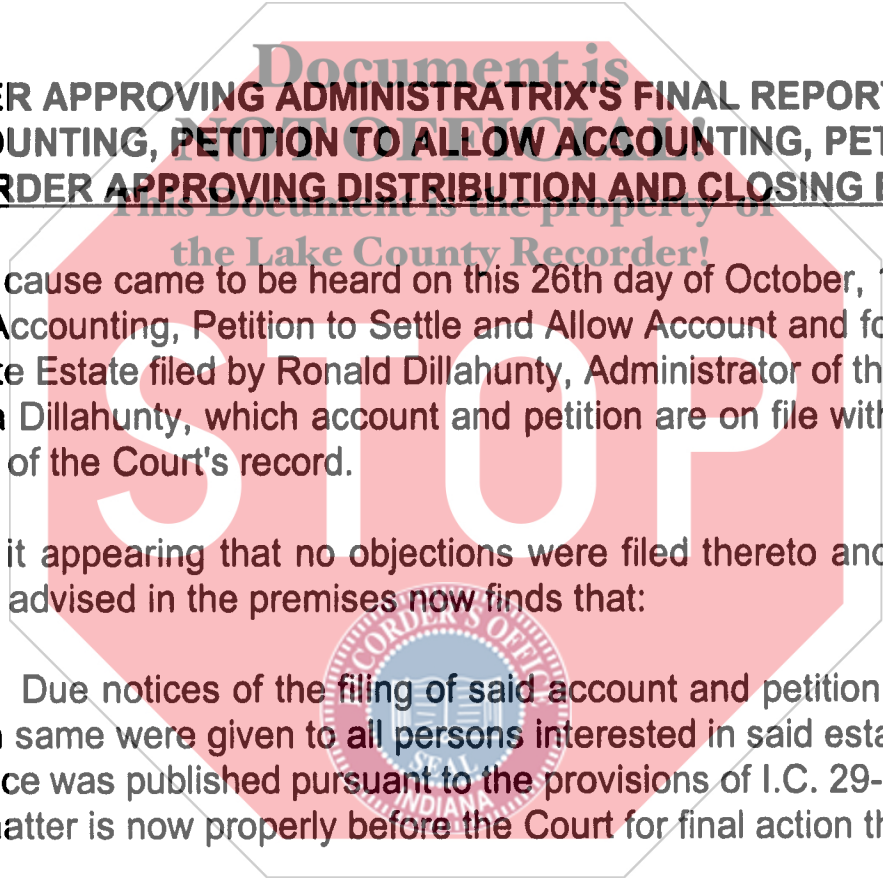

This cause came to be heard on this 26th day of October, 1999, upon the Final Accounting, Petition to Settle and Allow Account and for Authority to Distribute Estate filed by Ronald Dillahunty, Administrator of the Estate of Mae Clista Dillahunty, which account and petition are on file with the Court and a part of the Court's record.

And it appearing that no objections were filed thereto and the Court being fully advised in the premises now finds that:

1. Due notices of the filing of said account and petition and of the hearing on same were given to all persons interested in said estate. That a formal notice was published pursuant to the provisions of I.C. 29-1-16-6 and that this matter is now properly before the Court for final action thereon.
2. That Mae Clista Dillahunty died intestate, a resident of the County of Lake, State of Indiana on the 3rd day of October, 1998, and this Court appointed the said Ronald Dillahunty as Administrator of decedent's estate said Administrator was issued Letters Testamentary on the 11th day of December, 1998 and since that date has continued to serve in such capacity.

4. That more than five (5) months have elapsed since the date of the first (1st) published notice to the heirs and creditors of said decedent. IT IS THEREFORE, ORDERED, ADJUDGED and DECREED by the Court as follows:

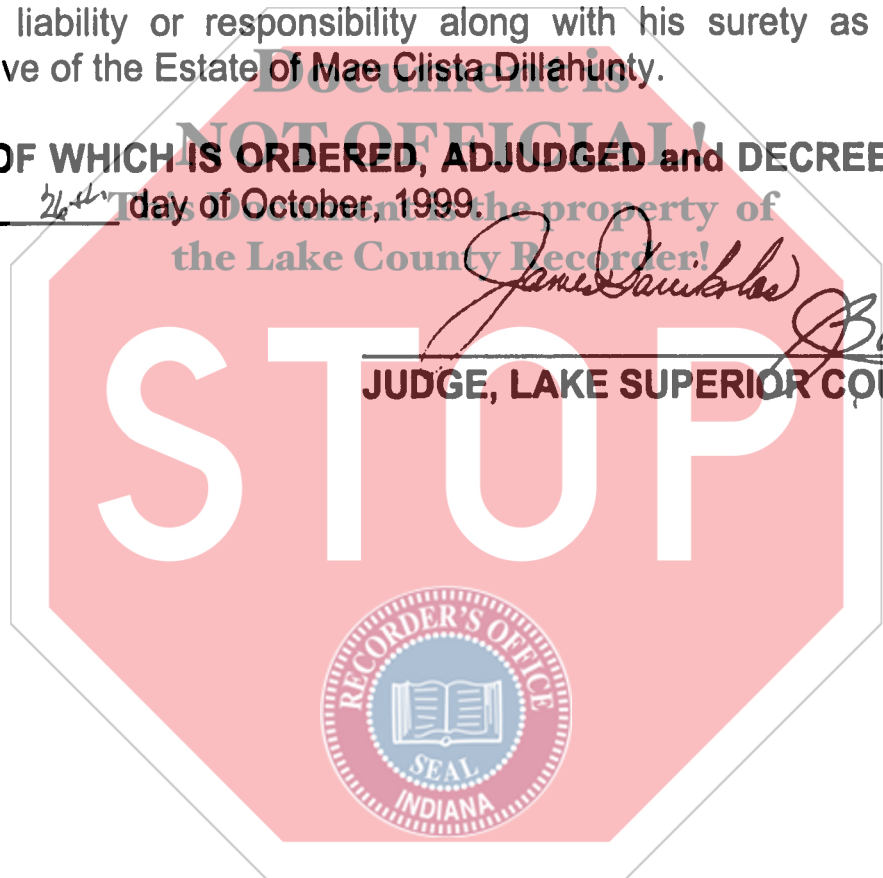
1. That said final report and account of said Administrator is hereby in all things settled, approved and confirmed.
