KNOW ALL MEN BY THESE PRESENTS:

This power of attorney shall remain effective until the same is revoked by written instrument recorded in the Recorder's Office of Lake County, Indiana.

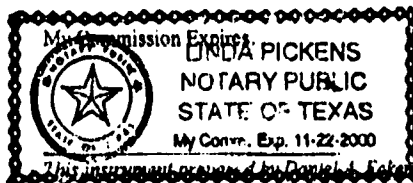
