RELEASE OF EASEMENT FOR ELECTRICAL & GAS LINES

THIS INDENTURE WITNESSETH: That NORTHERN INDIANA PUBLIC SERVICE COMPANY, an Indiana corporation, the holder of an easement for Electrical and Gas Lines executed by Mercantile Nat. Bank of Indiana as Trustee* dated June 30, 1978, recorded August 4, 1978, in Document #483187, in the Recorder's Office of Lake County, Indiana, in consideration of one dollar (\$1.00) in hand paid, the receipt whereof is hereby acknowledged does hereby REMISE, RELEASE AND FOREVER QUIT CLAIM to said Grantor and to their successors and assigns, all the right, title and interest acquired under the aforesaid easement for electrical lines and gas lines in, upon, along and over the premises situated in Lake County, Indiana, described as follows:

* under Trust Agreement number 3671 dated January 16, 1978

A strip of land in the North half of the Northeast Quarter of Section 27, Township 35 north, Range 8 west of the Second Principal Meridian, said strip being 15 feet wide, lying 7.5 feet each side of a centerline and said centerline produced, said centerline being described as follows:

Beginning at a point on the east line of said Northeast Quarter, said point being 638.00 feet south of the Northeast Corner of the Northeast Quarter of said Section 27; thence west parallel with the north line of said Section 27 a distance of 154.50 feet to the true point of beginning; thence north parallel with the east line of said Section 27 a distance of 181.50 feet.
