**AFFIDAVIT OF SURVIVORSHIP**

Comes now FRANK M. MAYER, being duly sworn upon his oath, and states as follows:

That FRANK MAYER is the owner in fee simple of the following described real estate located in Lake County, Indiana, more particularly described as follows:

Lot Number Thirty five (35), in Block Number Five (5), as marked and laid down on the recorded plat of EASTGATE subdivision in the City of Hammond, Lake County, Indiana, as the same appears of record in Plat Book 30, page 16 in the Recorder's Office of Lake County, Indiana.

That FRANK MAYER and decedent, MARYELLEN MAYER, were married on the 8th day of April, 1950. That FRANK MAYER and MARYELLEN MAYER were husband and wife at the time they acquired title to said real estate by deed of conveyance dated the 29th day of March, 1955, which deed is recorded in the Office of the Lake County Recorder.

That the marital relationship which existed between MARYELLEN MAYER and FRANK M. MAYER continued unbroken from the time they so acquired title to said real estate until the death of MARYELLEN MAYER on the 15th day of May, 1994, at which time FRANK M. MAYER acquired title to the real estate as surviving joint tenant by the entireties.

That the gross value of the estate of the decedent, MARYELLEN MAYER, as determined for the purpose of Federal Estate Taxes, was less than the value required for the filing, and the decedent's estate was not subject to Federal Estate Tax. That the decedent's estate was not subject to Indiana Inheritance Taxes. That the affiant is familiar with these facts insofar as he is the surviving spouse of MARYELLEN MAYER.
