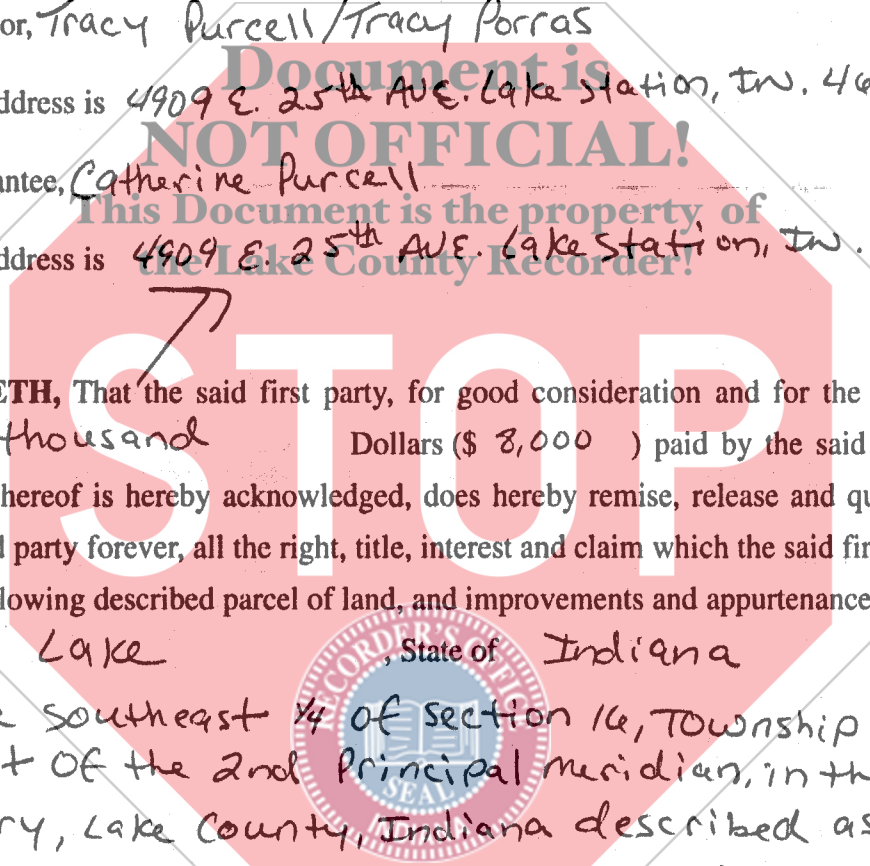
THIS QUITCLAIM DEED, Executed this 29 day of October, 1999 (year),
