### TAX TITLE DEED TO COUNTY

WHEREAS, Lake County did, on the 3rd day of November, 1999 produced to the County of Lake in the State of Indiana, a certificate of sale dated the 15<sup>th</sup> day of March, 1999 signed by Peter Benjamin who, at the date of sale, was Auditor of the County, from which it appears that said County on the 15<sup>th</sup> day of March, 1999 obtained, pursuant to law, the real property described in this indenture for the sum of Eight Thousand Five Hundred Seven Dollars and sixty cents (\$8,507.60), being the amount due on the following tracts of land returned delinquent in the name GENTRY ELOISE for 1998 and prior years, namely:
