DESCRIPTION

All that part of the Northeast Quarter of Section 21, Township 33 North, Range 9 West, of the Second Principal Meridian, lying Easterly of the Easterly Right of way Line of the Chicago, Indiana and Southern Railroad Company (New York Central Railway) excepting the South 330 Feet, also excepting the Northeast Quarter of the Northeast Quarter of said Section 21 and also excepting the following described parcel being more particularly described as follows:
