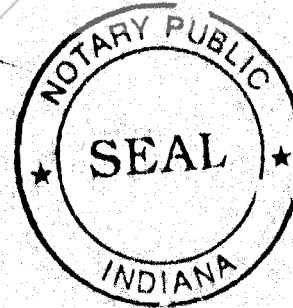

Part of the East half of the Northwest Quarter of Section 15, Township 35 North, Range 8 West of the 2nd P.M., described as follows, to-wit: Commencing at a point which is 245 feet East of the Southwest corner of Lot 13, in Block 1, in Part No. 2 of Merrill Heights Subdivision in Lake county, Indiana, as per plat thereof recorded in Plat Book 28, page 58, in the Recorder's Office of Lake County, Indiana, which commencement point is on the North Right-of-way line of Ridge Avenue, said Ridge Avenue being as shown on said recorded plat of said Merrill Heights Subdivision, thence East 90 feet along the said North Right-of-way line of said Ridge Avenue; thence North along a line parallel with the West lines of said Lot 13 and Lot 14, in Block 1, in Part No. 2 of said Merrill Heights Subdivision, a distance of 160 feet; thence West 90 feet; and thence South along a line parallel with the West lines of said Lot 13 and said Lot 14, a distance of 160 feet to the place of commencement, in Lake County, Indiana.
