and the said Surety shall be relieved of any further liability under this bond thirty (30) days after receipt of said notice by the said
Oblige.

The term of this bond is for a period commencing January 6, 2000
and terminating January 6, 2001 and may be continued from
year to year by continuation certificate executed by said Surety.

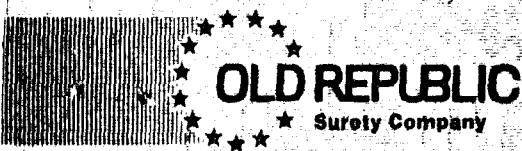

POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That OLD REPUBLIC SURETY COMPANY, a Wisconsin stock insurance corporation, does make, constitute and appoint:
