PARTIAL RELEASE OF MORTGAGE



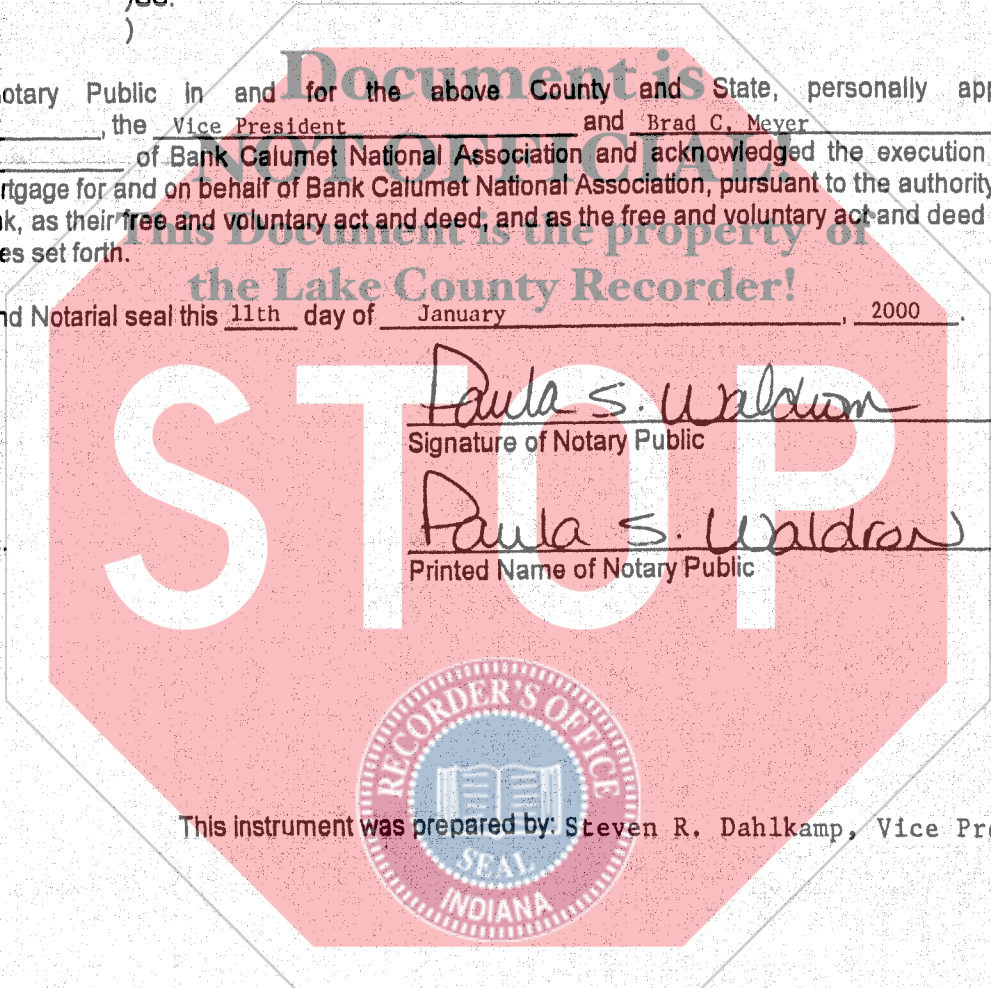
