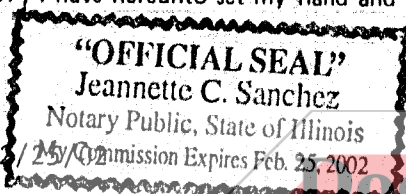

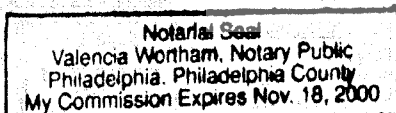

Riordan, Thomas E. Riordan, William F.
