AMENDED JUDGMENT

And comes now Attorney Jerry T. Jarrett, Attorney for Plaintiff herein, and files Affidavit of Non-Military Service of the herein defendants which Affidavit is in these words (H.I.).

Thereupon this cause is submitted to the Court for hearing and trial without the intervention of a jury and the Court having heard all of the evidence and being duly advised in the premises, now finds that LATASHA FORD, on whose behalf this action was filed, is the fee simple owner of the following real estate in Lake County, Indiana, to wit:

Lot 5, Block 7, Marshalltown Terrace, in the City of Gary, as shown in Plat Book 30, Page 12, Lake County, Indiana and more commonly known as 1301 Marshall Street, Gary, Indiana.

The Court further finds that the none of the Defendants have any right, title or interest in and to said described real estate, or any part thereof, and that LATASHA FORD'S title thereto should forever be quieted and set at rest as against each and all of the claims of all of the Defendants herein.
