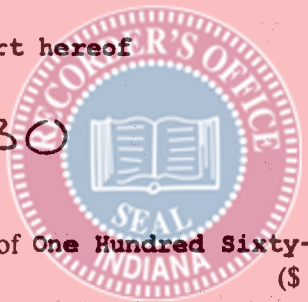

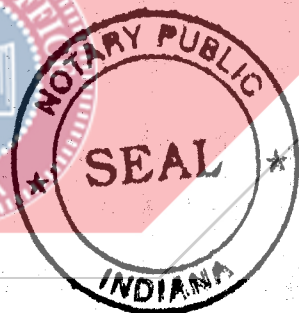
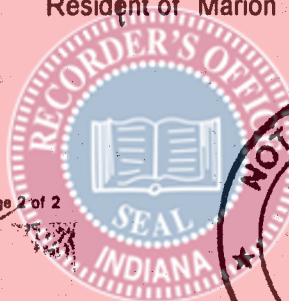

Legal Description
