ACKNOWLEDGEMENT OF PAYMENT OF ADDITIONAL CONSIDERATION
(RIGHT OF WAY AND EASEMENT GRANT)**

This Acknowledgment dated this 11 day of December, 1999, by Michael J. Koch, whose mailing address is 5400 E. 81st Ave., Merrillville, IN 46410- (hereinafter called "Grantor").

WHEREAS, by Right-of-Way and Easement Grant (hereinafter the "Right-of-Way") dated January 29, 1999, and recorded at Document Number: 99025213, Lake County, Illinois Recorder's Office, Grantor, or Grantor's predecessors in title, have granted, warranted and conveyed unto Vector Pipeline L.P., 21 West Superior Street, Duluth, Minnesota 55802, (hereinafter the "Grantee"), a Right-of-Way on the terms and conditions therein set forth, covering the strips of land specifically described in Exhibit A attached to the Right-of-Way, and

WHEREAS, paragraph numbered SECOND of said Right-of-Way provides that prior to installation of the pipeline described therein, Grantee shall pay additional consideration to Grantor, in accordance with the Agreement dated January 29, 1999 by and between Grantor and Grantee (hereinafter the "Agreement"), and

WHEREAS, the continuing effectiveness of the Right-of-Way requires Grantee to pay to Grantor such additional consideration on or before December 31, 1999.

NOW, THEREFORE, the Grantor acknowledges the following:

1. That the additional consideration called for in the Right-of-Way and in the Agreement was timely and properly paid by Grantee to Grantor, in compliance with the terms and conditions of the Right-of-Way and of the Agreement.
2. That the Right-of-Way is, and shall remain, in full force and effect as a permanent and perpetual conveyance of Right-of-Way, subject to the terms and provisions set forth therein.
3. This Acknowledgment is executed and may be recorded to provide record public notice of the foregoing facts.

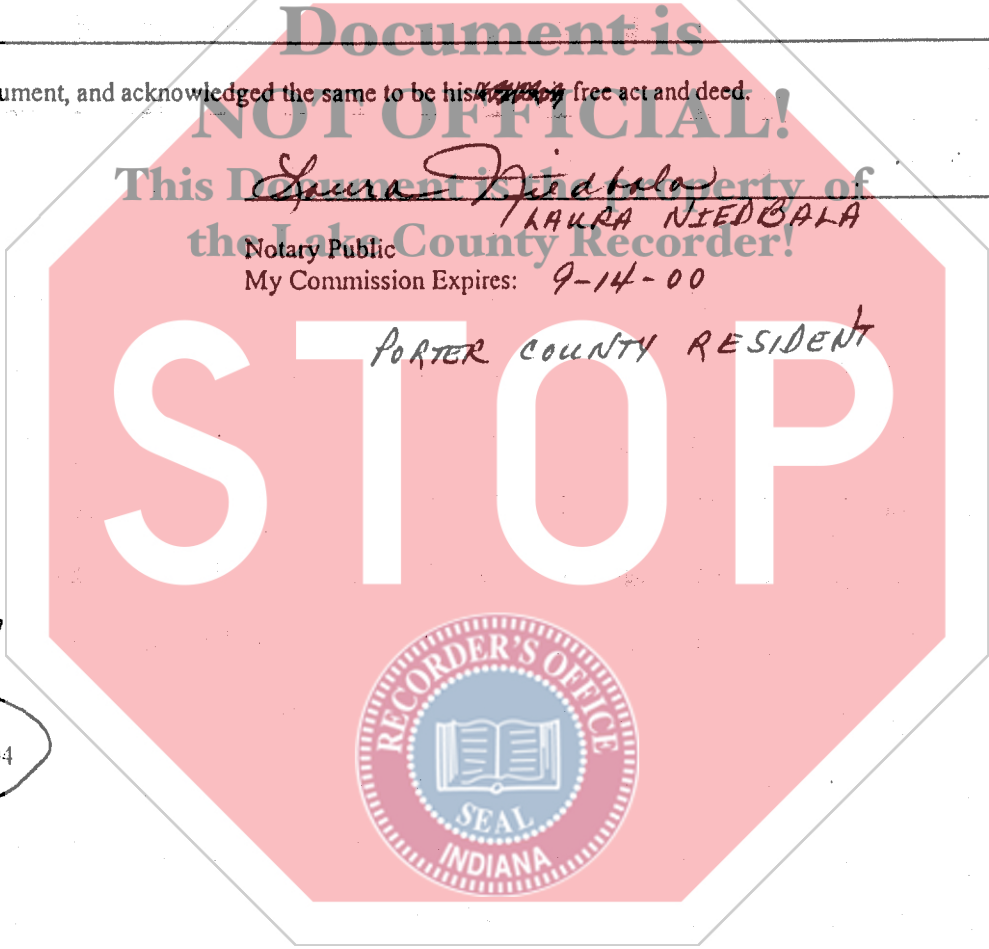
