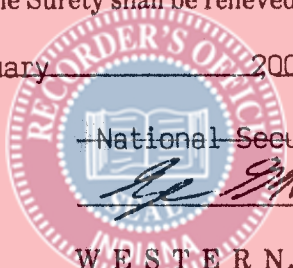
THE CONDITION OF THIS OBLIGATION IS SUCH That whereas, the Principal has been licensed As a Security & Alarm System Installer

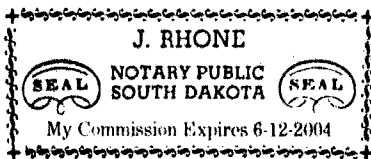
