WHEREAS, Lake County did, on the 3rd day of November, 1999 produced to the County of Lake in the State of Indiana, a certificate of sale dated the 15th day of March, 1999 signed by Peter Benjamin who, at the date of sale, was Auditor of the County, from which it appears that said County on the 15th day of March, 1999 obtained, pursuant to law, the real property described in this indenture for the sum of Six Thousand Three Hundred Eighty Five Dollars and seventeen cents (\$6,385.17), being the amount due on the following tracts of land returned delinquent in the name RAWLINS AUBREY for 1998 and prior years, namely:
