TAX TITLE DEED TO COUNTY

WHEREAS, Lake County did, on the 6th day of December, 1999 produced to the County of Lake in the State of Indiana, a certificate of sale dated the 15th day of March, 1999 signed by Peter Benjamin who, at the date of sale, was Auditor of the County, from which it appears that said County on the 15th day of March, 1999 obtained, pursuant to law, the real property described in this indenture for the sum of Four Thousand One Hundred Forty Dollars and twenty nine cents (\$4,140.29), being the amount due on the following tracts of land returned delinquent in the name DAVIS MARY A for 1998 and prior years, namely:
