### TAX TITLE DEED TO COUNTY

WHEREAS, Lake County did, on the 6<sup>th</sup> day of December, 1999 produced to the County of Lake in the State of Indiana, a certificate of sale dated the 15<sup>th</sup> day of March, 1999 signed by Peter Benjamin who, at the date of sale, was Auditor of the County, from which it appears that said County on the 15<sup>th</sup> day of March, 1999 obtained, pursuant to law, the real property described in this indenture for the sum of Thirteen Thousand Three Hundred Eighty Three Dollars and twenty two cents (\$13,383.22), being the amount due on the following tracts of land returned delinquent in the name EDDIE D. BOROM, EUGENE BOROM & JOSEPH BOROM for 1998 and prior years, namely:

Such real property has been recorded in the Office of the Lake County Auditor as delinquent for the nonpayment of taxes and proper notice of the sale has been given.
