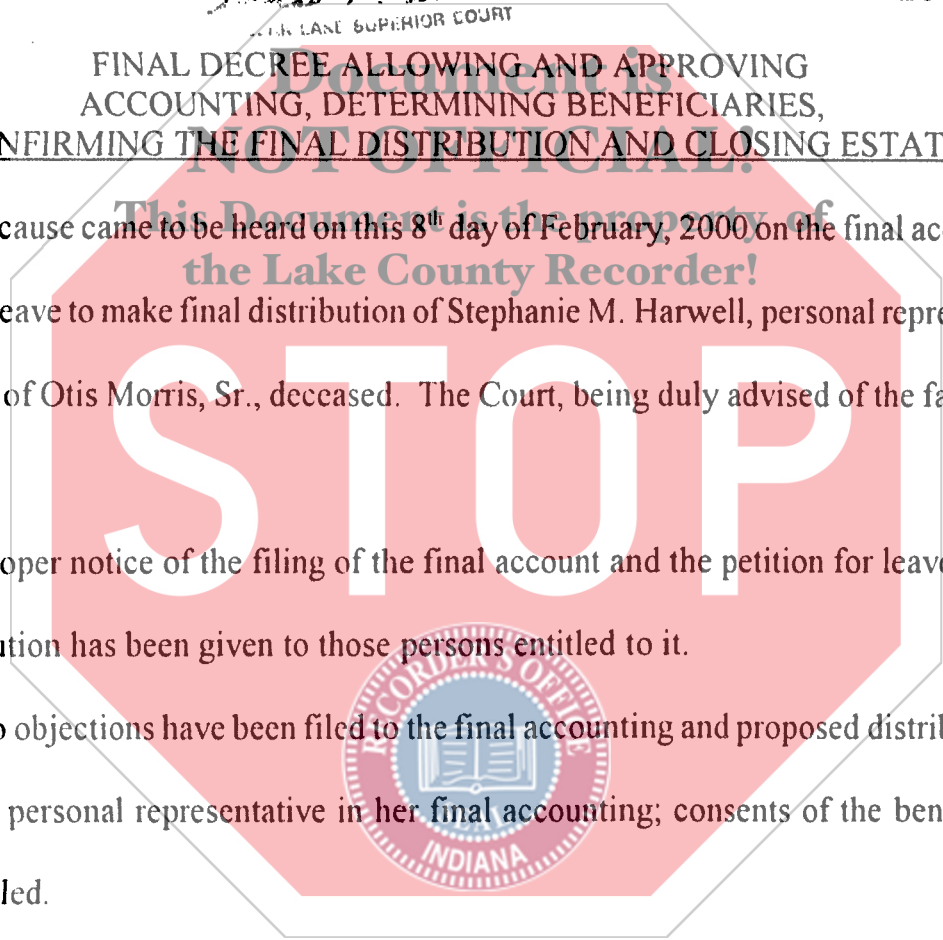

FINAL DECREE ALLOWING AND APPROVING
ACCOUNTING, DETERMINING BENEFICIARIES,
CONFIRMING THE FINAL DISTRIBUTION AND CLOSING ESTATE

This cause came to be heard on this 8th day of February, 2000 on the final account and petition for leave to make final distribution of Stephanie M. Harwell, personal representative of the estate of Otis Morris, Sr., deceased. The Court, being duly advised of the facts, finds that:

1. Proper notice of the filing of the final account and the petition for leave to make final distribution has been given to those persons entitled to it.
2. No objections have been filed to the final accounting and proposed distribution set forth by the personal representative in her final accounting; consents of the beneficiaries have been filed.
3. The calendar date of the first published notice of the appointment of the personal representative is more than five months in the past.
4. The claims filed in the administration of this estate and all other known debts of the decedent and of his estate have been paid, discharged, or released.
5. All Indiana inheritance taxes, federal or state income taxes owed by the decedent, and all federal estate or generation-skipping transfer taxes have been determined and paid.
