TAX TITLE DEED TO COUNTY

WHEREAS, Lake County did, on the 7th day of February, 2000 produced to the County of Lake in the State of Indiana, a certificate of sale dated the 20th day of September, 1999 signed by Peter Benjamin who, at the date of sale, was Auditor of the County, from which it appears that said County on the 20th day of September, 1999 obtained, pursuant to law, the real property described in this indenture for the sum of Nine Thousand Six Hundred Seventy Six Dollars and Fifty Three Cents (\$9,676.53), being the amount due on the following tracts of land returned delinquent in the name BURNS WALTER J. & NADINE for 1998 and prior years, namely:

Such real property has been recorded in the Office of the Lake County Auditor as delinquent for the nonpayment of taxes and proper notice of the sale has been given. 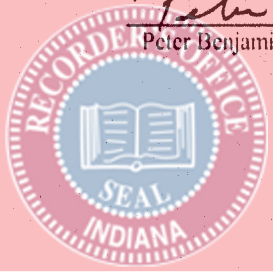
To have and to hold such real property, with the appurtenances belonging thereto, in as full and ample a manner as the Auditor of said County is empowered by law to convey the same.
