### TAX TITLE DEED TO COUNTY

WHEREAS, Lake County did, on the 7<sup>th</sup> day of February, 2000 produced to the County of Lake in the State of Indiana, a certificate of sale dated the 20<sup>th</sup> day of September, 1999 signed by Peter Benjamin who, at the date of sale, was Auditor of the County, from which it appears that said County on the 20<sup>th</sup> day of September, 1999 obtained, pursuant to law, the real property described in this indenture for the sum of Eleven Thousand Sixteen Dollars and Sixty Five Cents (\$11,016.65), being the amount due on the following tracts of land returned delinquent in the name CHIMIEL STANLEY J. & GIZELLA E. for 1998 and prior years, namely:

Such real property has been recorded in the Office of the Lake County Auditor as delinquent for the nonpayment of taxes and proper notice of the sale has been given.
