

TAX DEED

WHEREAS KCCI did the January 13th, 2000 produce to the undersigned, PETER BENJAMIN Auditor of the County of LAKE in the State of Indiana, a certificate of sale dated the September 23rd, 1998, signed by PETER BENJAMIN who, at the date of sale, was Auditor of the County, from which it appears that KCCI on the September 23rd, 1998, purchased at public auction, held pursuant to law, the real property described in this indenture for the sum of Two Thousand Seven Hundred Four Dollars and sixty-four cents (\$2,704.64), being the amount due on the following tracts of land returned delinquent in the name LAKICH BOB for 1997 and prior years, namely:
