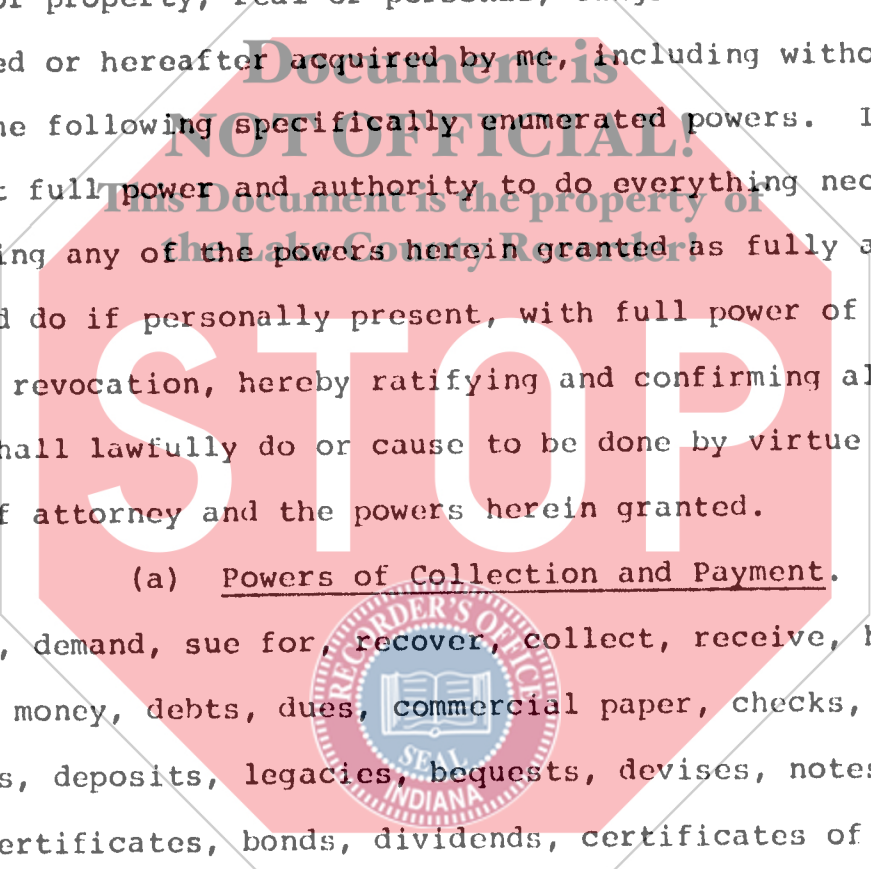
GENERAL POWER OF ATTORNEY

I, Magdalene Labik

, the principal, of Lake County, Indiana,
designate Rose J. Parlock of Lake County, Indiana,
my attorney in fact and agent (subsequently called agent) in my
name and for my benefit:

1. General Grant of Power. To exercise or perform any
act, power, duty, right or obligation whatsoever that I now have
or may hereafter acquire, relating to any person, matter, trans-
action or property, real or personal, tangible or intangible,
now owned or hereafter acquired by me, including without limita-
tion, the following specifically enumerated powers. I grant to
my agent full power and authority to do everything necessary in
exercising any of the powers herein granted as fully as I might
or could do if personally present, with full power of substitu-
tion or revocation, hereby ratifying and confirming all that my
agent shall lawfully do or cause to be done by virtue of this
power of attorney and the powers herein granted.

(a) Powers of Collection and Payment. To forgive,
request, demand, sue for, recover, collect, receive, hold all such
sums of money, debts, dues, commercial paper, checks, drafts,
accounts, deposits, legacies, bequests, devises, notes, interests,
stock certificates, bonds, dividends, certificates of deposit,
U.S. Treasury Bills and Notes, annuities, pension, profit sharing,
retirement, social security, insurance and other contractual
benefits and proceeds, all documents of title, all property, real
or personal, intangible or tangible property and property rights,
and demands whatsoever, liquidated and unliquidated, now or here-
after owned by, or due, owing, payable or belonging to, me or in
which I have or may hereafter acquire an interest; to have, use
and take all lawful means and equitable and legal remedies and
proceedings in my name for the collection and recovery thereof,

and to adjust, sell, compromise, and agree for the same and to execute and deliver for me, on my behalf, and in my name, all endorsements, releases, receipts or other sufficient discharges for the same;

(b) Power to Acquire and Sell. To acquire, purchase, exchange, grant options to sell, and sell and convey real or personal property, tangible or intangible, or interests therein, on such terms and conditions as my agent shall deem proper;

(c) Management Powers. To maintain, repair, improve, invest, manage, insure, rent, lease, encumber, and in any manner deal with any real or personal property, tangible or intangible, or any interest therein, that I now own or may hereafter acquire, in my name and for my benefit, upon such terms and conditions as my agent shall deem proper;

(d) Banking Powers. To make, receive and endorse checks and drafts, deposit and withdraw funds, acquire and redeem certificates of deposit or U.S. Treasury Bills, Notes or Bonds, in banks, savings and loan associations and other institutions, execute or release such deeds of trust or other security agreements as may be necessary or proper in the exercise of the rights and powers herein granted;

(e) Tax Powers. To prepare, sign and file joint or separate income tax returns or declarations of estimated tax for any year or years; to prepare, sign and file gift tax returns with respect to gifts made by me for any year or years; to consent to any gift and to utilize any gift-splitting provision or other tax election; and to prepare, sign and file any claims for refund of any tax;

(f) Safe Deposit Boxes. To have access at any time or times to any safe deposit box rented by me, wheresoever located and to remove all or any part of the contents thereof,

and to surrender or relinquish said safe deposit box, and any institution in which any such safe deposit box may be located shall not incur any liability to me or my estate as a result of permitting my agent to exercise this power.

2. Interpretation and Governing Law. This instrument is to be construed and interpreted as a general power of attorney. The enumeration of specific powers herein is not intended to, nor does it, limit or restrict the general powers herein granted to my agent. This instrument is executed and delivered in the State of Indiana, and the laws of the State of Indiana shall govern all questions as to the validity of this power and the construction of its provisions.

3. Third-Party Reliance. Third parties may rely upon the representations of my agent as to all matters relating to any power granted to my agent, and no person who may act in reliance upon the representations of my agent or the authority granted to my agent shall incur any liability to me or my estate as a result of permitting my agent to exercise any power.

4. Disability of Principal. This General Power of Attorney shall not be affected by my disability.
