follows:

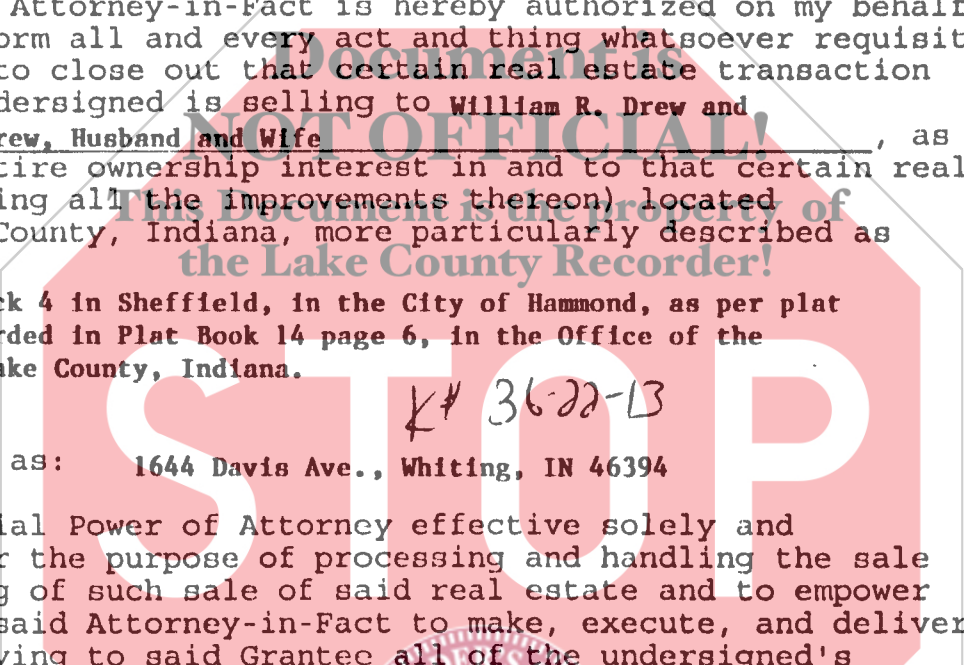
Lot 13 in Block 4 in Sheffield, in the City of Hammond, as per plat
