A., formerly known as Gainer Bank, N.A. 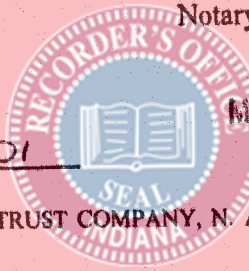
