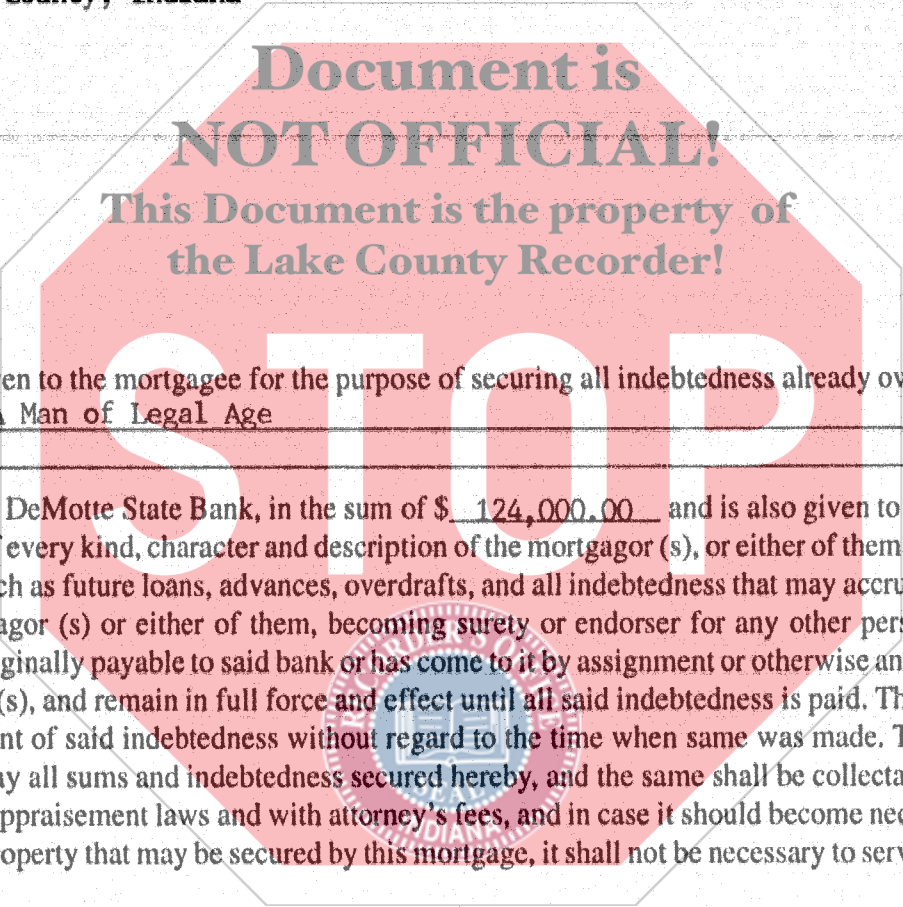
**INDEMNIFYING MORTGAGE**

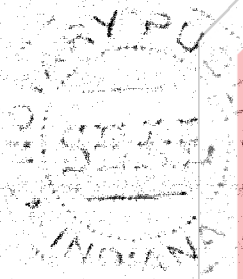
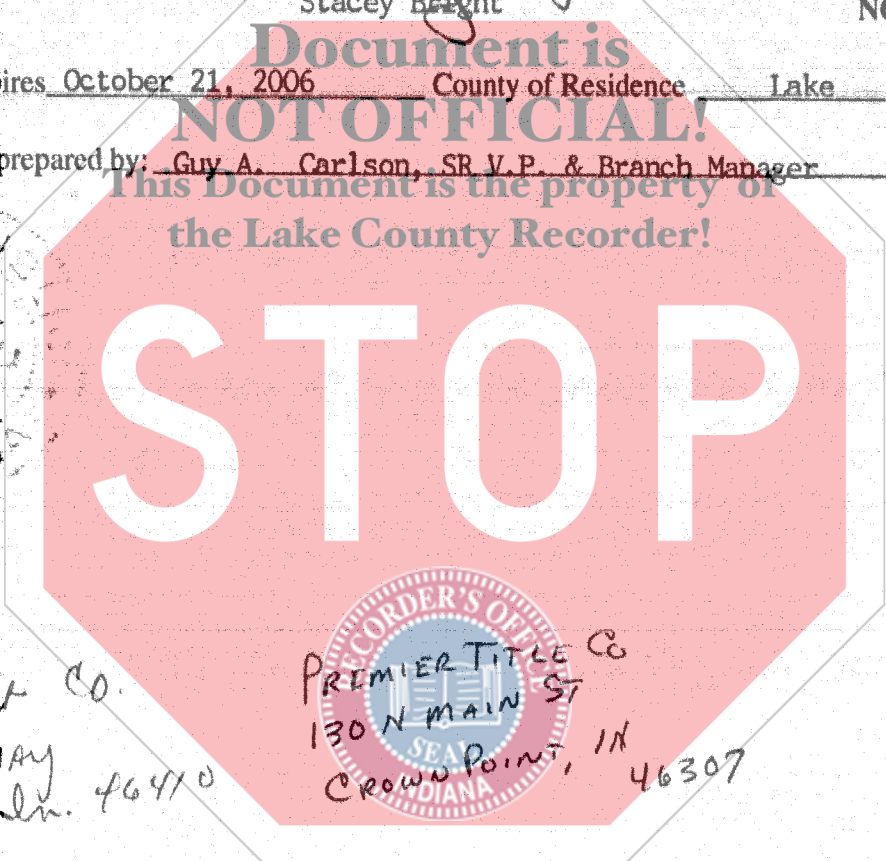
