TAX TITLE DEED TO COUNTY

WHEREAS, Lake County did, on the 22nd day of October, 1998 produced to the County of Lake in the State of Indiana, a certificate of sale dated the 11th day of February, 1998 signed by Sam Orlich who, at the date of sale, was Auditor of the County, from which it appears that said County on the 11th day of February, 1998 obtained, pursuant to law, the real property described in this indenture for the sum of Twenty Nine Thousand Two Hundred Ninety One Dollars and Sixty One Cents (\$29,291.61), being the amount due on the following tracts of land returned delinquent in the name DISCOUNT OUTLET INC for 1997 and prior years, namely:
