To make demand(s) on behalf of the Trustee upon any or all parties liable on any Home Equity Loan; to give notices of intention to accelerate, to give notices of acceleration and any other notices as the Servicer deems appropriate; to post all notices as required by law and the documents securing any lorge Equity Loan in order to foreclose on any such Home Equity Loan; to handle all aspects of foreclosure on behalf of the Trustee including but not limited to conducting the preclosure sale bidding for the Trustee and executing all documents needed to effect such foreclosure sale; to file suit and prosecute legal actions against all parties liable for past due amounts under any Home Equity Loan, including but not limited to any deficiency amounts due following foreclosure; and/or to take such other actions and exercise such rights which may be taken by the Trustee under the terms of any Home Equity Loan including foreclosure, sale, taking possession of, realization upon or any other disposition of all or any part of any Home Equity Loan or any collateral therefor or guaranty thereof; in each case on behalf of the Trustee and pursuant to the terms of the Agreement.

The undersigned gives said Attorney-in-Fact full power and authority to execute such instruments and to do and perform all and every act and thing necessary and proper to carry into effect the power or powers granted by or under this Limited Power of Attorney as fully as the undersigned might or could do, and bereby does ratify and confirm to all that said Attorney-in-Fact shall lawfully do or cause to be done by authority hereoff.

This appointment shall apply only to transactions which the Frustee's authorized to enter into under the Agreement, but in no event shall apply to any transactions other than the above enumerated transactions. This Document is the property of
