LEGAL DESCRIPTION

Parcel 1: Part of the East 1/2 of the Southwest 1/2 of the Northeast 1/2 of the Southeast 1/2 of Section 29, Township 36 North, Range 7, West of the Second Principal Mcridian, in the City of Hobart, Lake County, Indiana, described as follows: Beginning at a point 30 feet East of the Southwest corner of said tract, thence North, parallel to the West line of said tract, 150 feet; thence East, parallel to the South line of said tract, 50 feet; thence South, parallel to the West line of said tract, 150 feet to the South line thereof, thence West along said South line, to the point of beginning.

Parcel 2: Part of the East ½ of the Southwest ¼ of the Northeast ¼ of the Southeast ¼ of Section 29, Township 36 North, Range 7 West of the Second Principal Meridian, in the City of Hobart, Lake County, Indiana, described as follows: Beginning at a point on the West line and 160 feet North of the Southwest corner thereof; thence East, parallel to the South line thereof, 155 feet; thence South 10 feet; thence East, parallel to the South line thereof, 25.92 feet; thence North 160.12 feet; thence West 180.92 feet to the West line thereof; thence South 150.1 feet to the point of beginning.

The West 30 feet of the above-described parcel is reserved for a private roadway.

Parcel 3: Part of the East 1/2 of the Southwest 1/2 of the Northeast 1/2 of the Southeast 1/2 of Section 29, Township 36 North, Range 7 West of the Second Principal Meridian, in the City of Hobart, Lake County, Indiana, described a follows: Beginning at a point on the West line 150 feet North of the Southwest corner of said track, thence East and parallel to the South line of said track a distance of 80 feet; thence North and parallel to the West line of said track a distance of 10 feet; thence West and parallel to the South line of said track a distance of 10 feet to point of beginning.
