Comes now GLORIA WARD, being duly sworn upon her oath and states as follows:

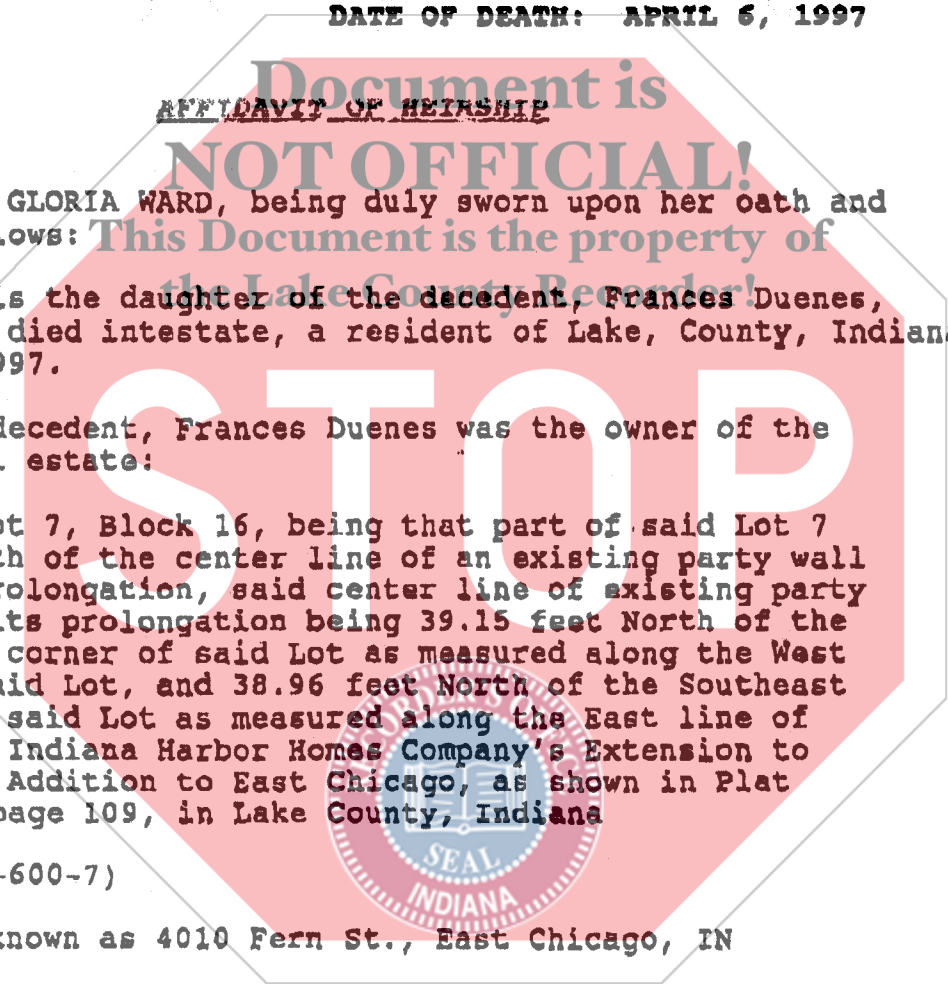
That she is the daughter of the decedent, Frances Duenes, deceased, who died intestate, a resident of Lake, County, Indiana on April 6, 1997.
