

TICOR TITLE : NSURANCE Crown Point, Indiana

That part of Lot 13 in Ellendale Farm Unit Two, in the City of Crown Point, as per plat thereof, recorded in Plat Book 84 page 30, in the Office of the Recorder of Lake County, Indiana, as amended by Certificates of Correction recorded June 26, 1998 as Document No. 98048173 and recorded September 30, 1998 as Document No. 98076917, lying Southeasterly of the following described line:

Commencing at the Southeast comer of said Lot 13; thence Northwesterly 63.95 feet along the Southwesterly line of said Lot 13 being the arc of a circle of 650.24 feet radius convex Southwesterly having a chord bearing of North 52 degrees 31 minutes 24 seconds West, to a point of reverse curve; thence Westerly 8.49 feet along the Southwesterly line of said Lot 13 being the arc of a circle of 60.00 feet radius convex Northerly, having a chord bearing of North 53 degrees 45 minutes 31 seconds West, to the Point of Beginning; thence North 35 degrees 47 minutes 43 seconds East 115.44 feet, to the Northerly line of said Lot 13 at a point 75.52 feet West of the Northeast corner of said Lot 13 (as measured along said Northerly line).
