LEGAL DESCRIPTION

PARCEL 10

That part of Block 4 in Park Place Addition to the Town of Highland, as per plat thereof, recorded in Plat Book 83 page 82, and amended by Plat of Correction recorded in Plat Book 84 page 34, and further amended by 2nd Plat of Correction recorded in Plat Book 85 page 61, in the Office of the Recorder of Lake County, Indiana, described as follows: Being the West 20.00 feet of that part of Block 4 lying East of the following described line: Commencing at the point of curve in Block 4, said point being on the North line of Block 4, and 40.00 feet West of the Northerly projection of the East line of said Block 4; thence South 86 degrees 45 minutes West on the North line of Block 4, a distance of 195.19 feet to the point of beginning and the Northwest corner of Parcel Ten; thence South 03 degrees 15 minutes West, a distance of 81.17 feet to the South line of Block 4 and the Southwest corner of Parcel Ten. Commonly known as 2916 Churchill Lane.
