Thence North along the East line of Kennedy Avenue Parallel with and 40 feet East of the West line of said Southwest 1/4 of the Northeast 1/4 a distance of 91.334 feet to the point of beginning.

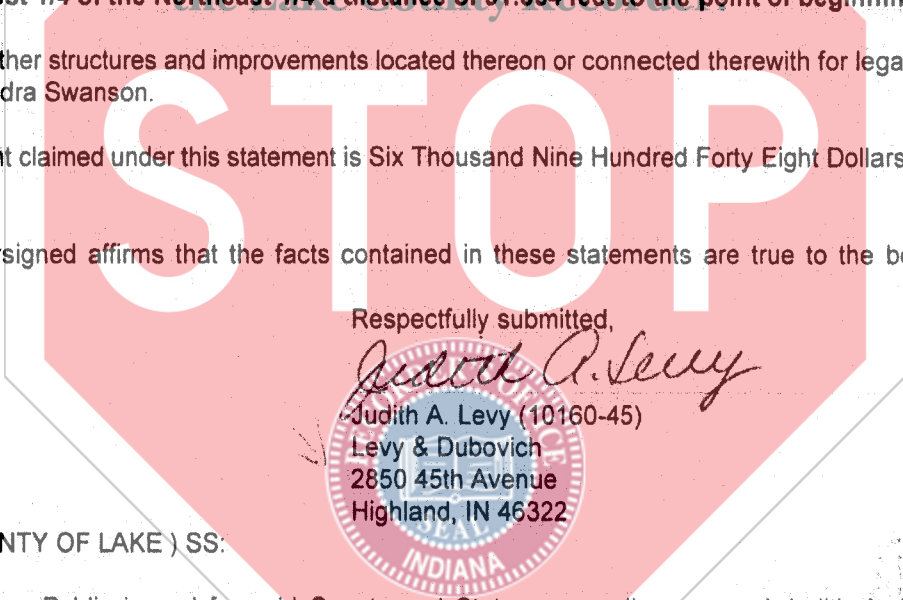
