5.1(b) The Board of Directors or President, Vice President, or other officer designated by them or either of them shall have power to appoint Attorneys-in-Fact and to authorize them to execute on behalf of the Company bonds and undertakings, recognizances, contracts of indemnity and other writings obligatory in the nature thereof, and to attack the seal of the Company thereto; and shall also have the power to remove any such Attorney-in-Fact at any time and revolte the power and authority given to him.
