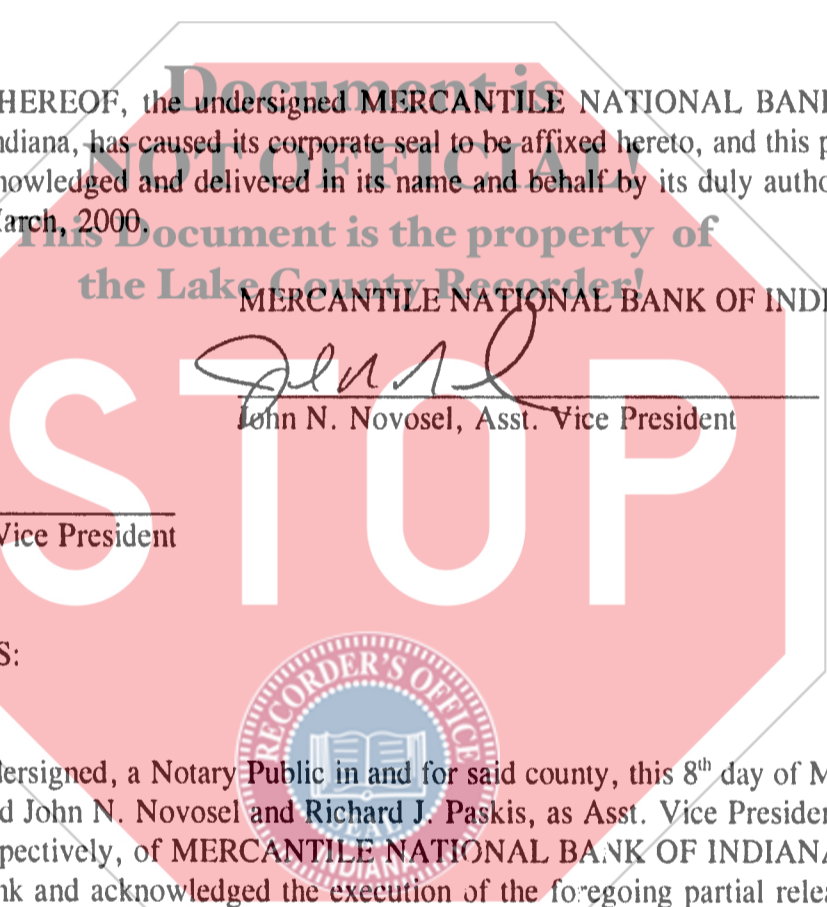
PARTIAL RELEASE OF MORTGAGE
