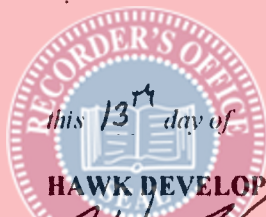
THIS DEED TAKEN SUBJECT TO: **TAX KEY # 13-700-14**
