The Unsafe Buildings Department further orders that this action be completed within FORTY-FIVE(45) DAYS WITH SUBSTANTIAL PROGRESS TO BE MADE WITHIN(30) DAYS FROM RECEIPT OF THIS ORDER

Should you disagree with the findings of this Order, you will have the right to appeal these findings before the Unsafe Buildings Hearing Authority at a meeting to be held on APRIL 19, 2000

AT 8:00 a.m. in the Conference Room of the Lake County Plan Commission. At that time you will have the right to appear either with or without counsel, to present witnesses or any evidence pertinent to this matter, or to make any argument in your favor.

Should you choose to comply with this Order, you must first obtain a Permit from the Lake County Planning & Building Department prior to the initiation of any work. If you choose to ignore this Order, the Hearing Authority shall take the necessary steps to ensure that the matter is satisfied and complies with Ordinance 1012-A.

Please advise this department of your intentions within ten (10) days of your scheduled appearance date before the Unsafe Buildings Hearing Authority. If you have any questions, contact this office.
