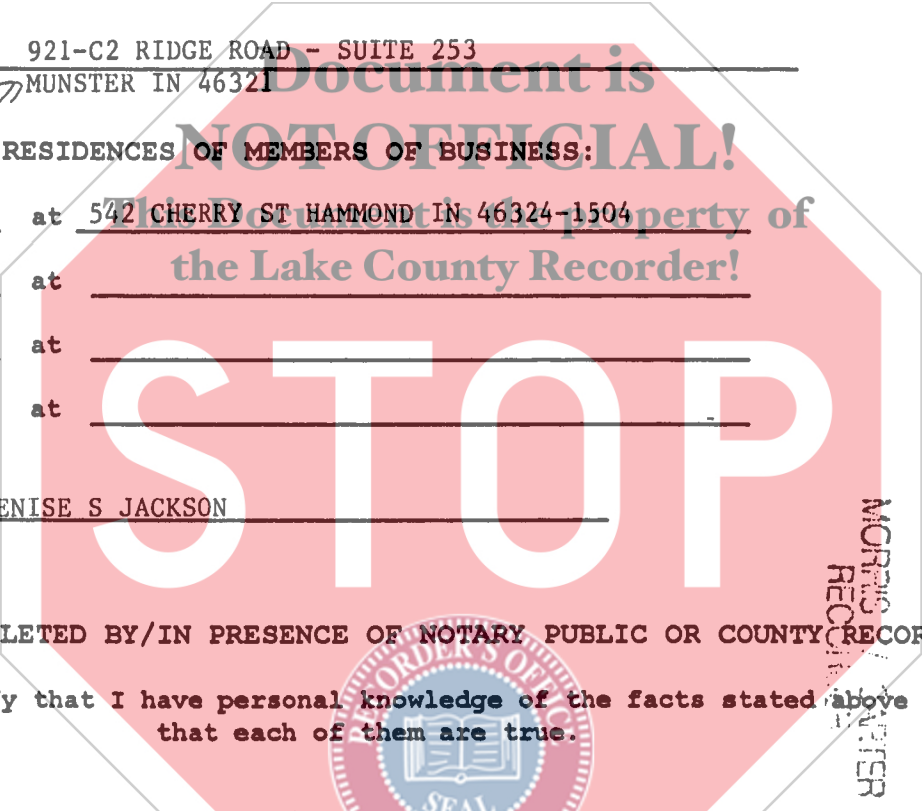

INSTRUCTIONS FOR CERTIFICATE OF ASSUMED BUSINESS NAME

Please read the following carefully before taking this form to the County Recorder's Office in each county where you plan to locate a place of business.

1. This form has been developed by the Department of Commerce to comply with the state requirement of registering your business name with the County Recorder. It should be acceptable in any county in Indiana. Some counties also have their own forms. Either form should accomplish the registration of your business name.
2. IF THIS FORM HAS BEEN FAXED TO YOU, YOU MUST COPY IT ONTO PLAIN PAPER before signing it and returning it to the Recorder's Office.
3. Some counties may require that this form be notarized by a Notary Public or certified by the County Recorder's Office, and there may be a nominal cost involved in either case. To avoid delays, we suggest that you contact the Recorder's Office before you go to turn in the form.
