### QUITCLAIM DEED

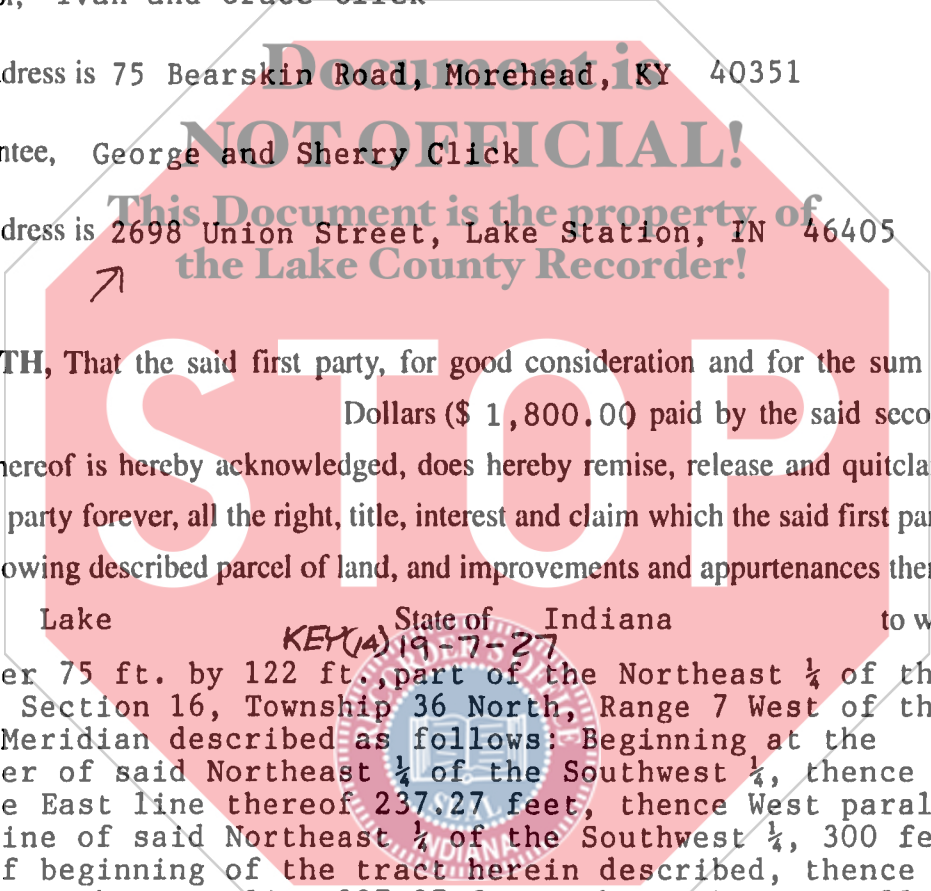
**THIS QUITCLAIM DEED**, Executed this 29 day of October, 1999 (year),
