Prepayment of the Purchase Price

Buyer shall have the privilege of paying without penalty, at any time, any sum or sums in addition to the payments herein required. Interest shall both accrue after the date on which Buyer makes any payment that constitutes full payment of the purchase price.

Payments made by Seller and all costs and expenses incurred by him in connection with the exercise of such right shall, at the option of Seller, either (a) be payable to Seller by Buyer within 30 days after demand, or (b) added to principal. In any event such payments and such costs and expenses shall bear interest from the respective dates of making payment or incurring costs and expenses.

Evidence of Title

- 1. If Buyer is not in default under this contract, Seller will furnish Buyer an owner's title insurance policy disclosing marketable title to the Real Estate to a date which is the earlier of (a) a date (after the date of this contract) specified by Buyer in a notice to Seller of (b) a date 60 days prior to the date the final installment under this contract is due.
- 2. A title insurance policy furnished under this contract shall be in the amount of the purchase price and shall be insured by an insurer satisfactory to Buyer.
- 3. Any further title evidence shall be at the expense of the Buyer, provided, however, that the cost of additional title evidence necessitated by the acts or omissions of Seller or by any judicial proceeding affecting the Real Estate shall be born by Seller.

Use of Real Estate by Buyer, Seller's Right to Inspection and Buyer's Responsibility for Injuries:
