This Indenture, Made this 3rd day of March, A.D. 2000 between John Buncich, Sheriff of Lake County, in the State of Indiana, of the first part and SECURITY FEDERAL BANK, a F.S.B. of the County of Lake and State of Indiana of the second part. WITNESSETH:
