Comes now Rosa Madrigal, your petitioner herein who being duly sworn under her oath respectfully lists the assets of the guardianship as follows:

1. Joint savings account #314730 in the amount of \$30,753.53 which is held at Citizens Financial Services. This money is what Victor has been receiving from Social Security benefits since the time of his father's death on February 1, 1997.

2. A CD account # 327938 in Victor R. Madrigal's name at Citizens Financial Services in the amount of \$4508.60. This money may not be withdrawn until Victor is 18 years of age.

3. In the petition that was filed in Court on February 2, 2000 I erroneously believed that Victor was entitled to a one fourth interest in real property located at 4006 and 4007 Deodar Street, East Chicago, Lake County, Indiana. Ticor Title has since advised me that title to said property is solely in my name since the property was held as Tenants by the Entirety by me and my late husband Gabriel E. Madrigal and only my husband transferred title to Victor R. Madrigal. Thus I am requesting an order indicating that this property is not part of the guardianship estate.

WHEREFORE, your petitioner prays that the Court enter an order finding:

1. That she has complied with her obligation to list assets of the Guardianship.
2. That the Court that the real property located at 4006 and 4007 Deodar Street, East Chicago, Indiana is not part of the Guardianship Estate.
3. And for all other relief which is proper in the premises.
