KNOW ALL MEN BY THESE PRESENTS, That we,

JOEL KENNEDY CONSTRUCTING CORP., 40 NOLL STREET, WAUKEGAN, IL 60085, as Principal,

and **OLD REPUBLIC SURETY COMPANY**, organized under the laws of the state of Wisconsin, as Surety, are held and firmly bound unto

This obligation may be cancelled by said Surety by giving thirty (30) days notice in writing of its intention to do so to said Obligee; and provided further, that nothing herein shall affect any rights of liabilities which shall have accrued under this bond prior to the date of termination; and the said Surety shall be relieved of any further liability under this bond thirty (30) days after receipt of said notice by the said Obligee.

The term of this bond is for a period commencing **3/20/2000** and terminating (or continuous) **3/20/2001** provided, however, this bond may be continued from year to year by continuation certificate executed by said Surety.

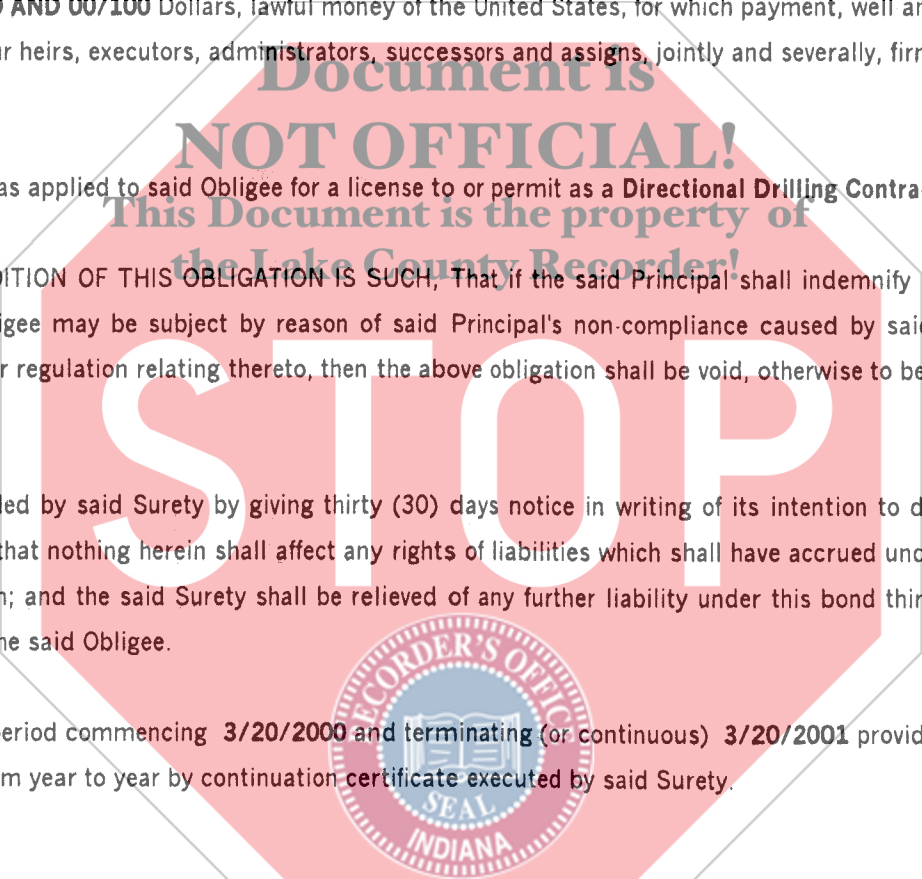

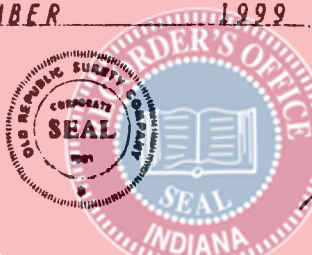
