Commonly known as 358 South Wabash Street, Hobart, Indiana 46342.

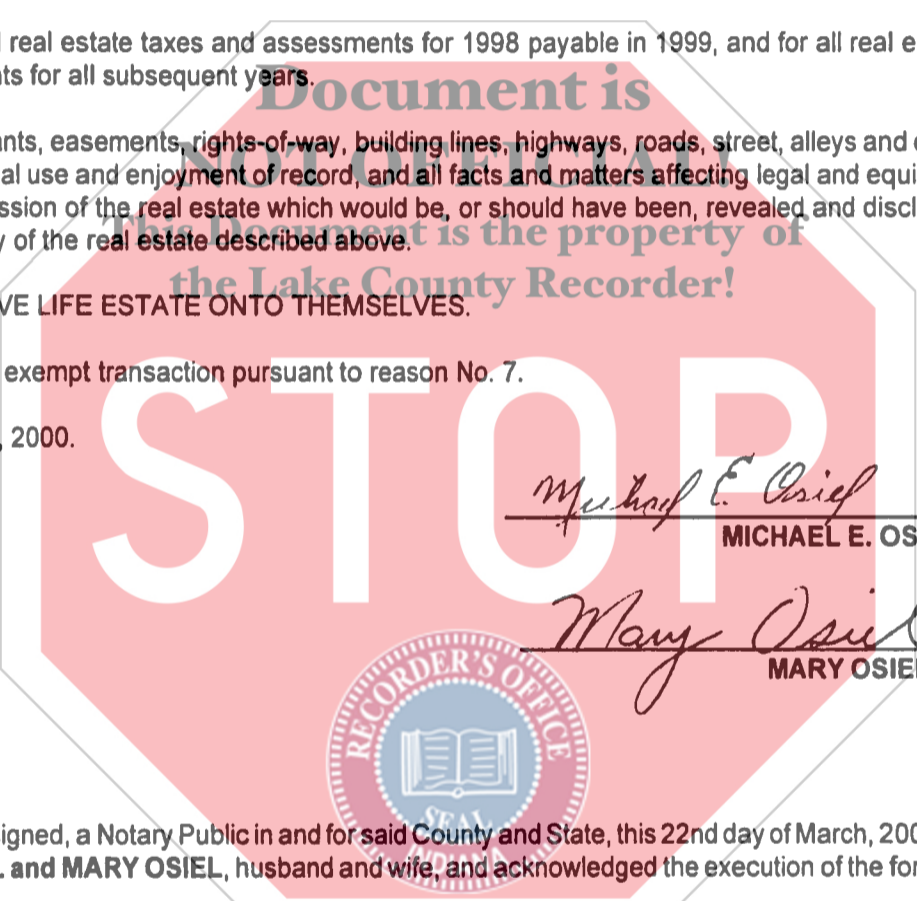
