RECITALS

A. By Right-of-Way and Easement Grant (hereinafter "Right-of-Way") dated June 10, 1999, and recorded June 25, 1999, as Document No. 99053183, in the Office of the Recorder of Lake County, Indiana, Linda L. Hasprunar and Florence Hasprunar, whose mailing address is 2107 E. 89th Ave., Merrillville, IN 46410 ("Grantor") granted, warranted and conveyed unto Vector, a pipeline easement and right-of-way; and

B. Paragraph numbered SECOND of said Right-of-Way provides that prior to installation of the pipeline described therein, Vector shall pay additional consideration to Grantor; and

C. The continuing effectiveness of the Right-of-Way requires Vector to pay to Grantor such additional consideration on or before December 31, 1999, and Vector wishes to acknowledge such payment.

NOW, THEREFORE, Vector swears and affirms under oath the following:

1. That the additional consideration called for in the Right-of-Way was timely and properly paid by Vector to Grantor in compliance with the terms and conditions of the Right-of-Way.
2. That the Right-of-Way is, and shall remain, in full force and effect as a permanent and perpetual conveyance of a Right-of-Way and easement, subject to the terms and provisions set forth therein and shall no longer be subject to defeasance.
3. This Certification has been executed and recorded to provide public notice of the foregoing facts.
