Indiana, as Surety, are held and firmly bound unto the

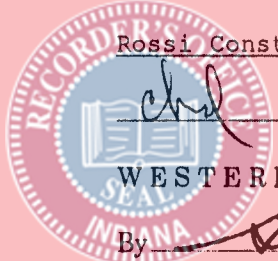

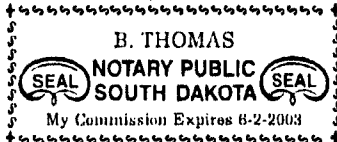

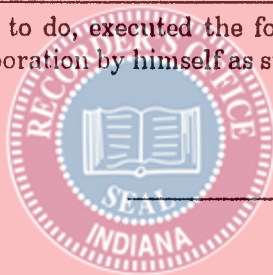
