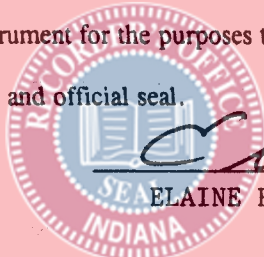

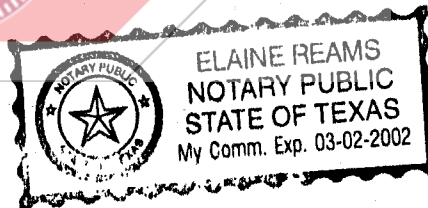


EXHIBIT A
