by the said Oblige.

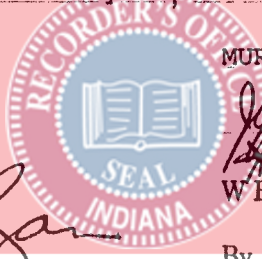
NOW THEREFORE, if the said Principal shall faithfully perform the duties and in all things

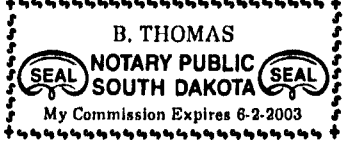
