# TAX DEED

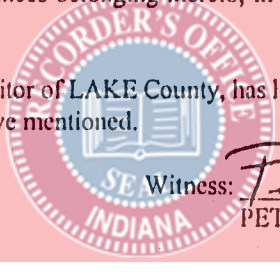
