successors and assigns, jointly and severally by these presents.

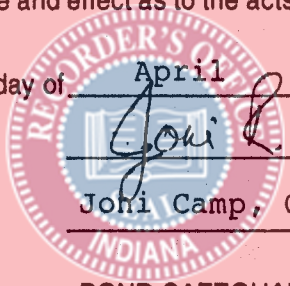
In consideration thereof, the Principal is granted a license and/or permit by the Obligee to engage in the

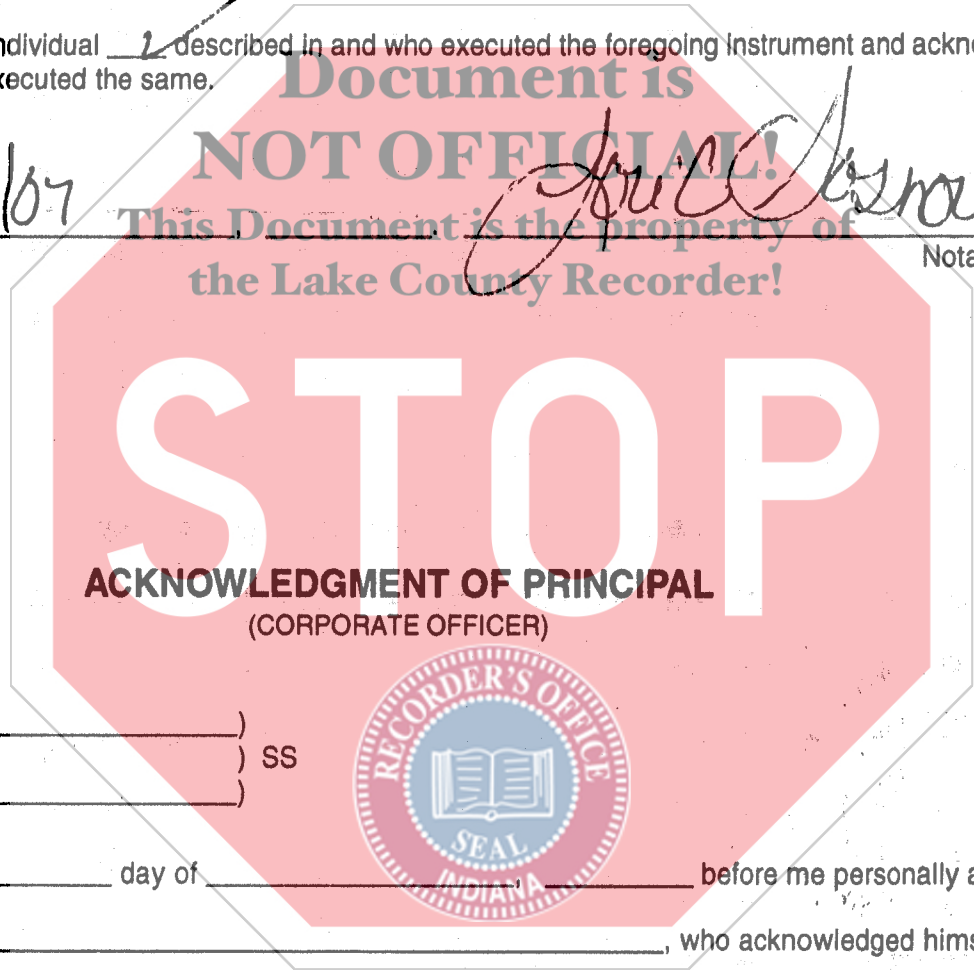
